As a result of discussion during the November 2024 meeting, the following changes have been made to policy:

- PR subcommittee guidelines have been added to policy.
- The statement "the guidelines of the NA Texas Website can only be changed by that committee" has been added to the guidelines for that subcommittee.
- The Rio Grande and Freedom areas have been removed from the rotation to host RSC meetings.

Per passed proposal, guidelines for behavior during RSC meetings have been added to policy in section two. We have had two policy task group meetings to discuss policy overhaul to align language with CBDM. This is an ongoing project. Thank you, Patsy, Deb and Ray, for your participation and guidance.

We completed our annual Convention EACNA Ten, and it turned out to be a complete success. Thanks to all of those that attended or assisted in any manner. We currently have 46 active Groups in or Area, both Live and Virtual. Esperanza Area currently holds 93 meetings weekly. 11 Meetings are on the virtual platform by 6 Groups, with 3 Groups exclusively virtual, and 3 Groups with one virtual and, and another "In Person" Meeting.

There is one Group that holds 8 Meetings weekly, 3 Groups that hold 7 Meetings weekly, 3 Groups that hold 4 Meetings weekly, and 1 Group that holds 3 Meetings weekly. 12 Groups that hold 2 Meetings weekly, and 14 Groups that meet once a week. There are 13 Groups that hold 20, "In Person" Meetings weekly out of town (San Antonio City limits). One of the Groups that holds both virtual and, "In Person" Meetings is Bi-lingual. We recently had one Group that has added a Spanish-Only Meeting in addition to the 3 other Meetings it conducts weekly.

Most of our Groups are doing well in their endeavor to continue to carry the message. We still have some outlying Groups that continue to struggle with attendance in their local Area. The RCM2 has been working diligently in that Area with some of those Groups, especially the Rio Grande Outlaw Group in Del Rio, Texas.

Other Groups having problems with attendance is the, Mind & Body Shop, located in Pleasanton, Texas and the New Beginnings Group of Narcotics Anonymous located in Eagle Pass, Texas.

We have been utilizing the NAWS Resources for Fellowship as a guiding tool. We believe that we are at the point where we need some type of activity in those areas to assist. But at this time, we have no Activities Facilitator, so we are on hold in that area for now.

Finally, we are continually facing the issue that no one is stepping up for Service. We have been asking our Groups for nominations since we held Elections in September.

Especially notable is the number of new members who meet the minimum clean time requirements are getting involved. Our PR efforts have been stymied since 2020 when Covid-19 reduced our meeting attendance so drastically and Zoom became the norm for almost a year. We have not gotten out of that all the way with many addicts still not doing face-to-face meetings. Our contacts have all changed since we were active years ago. Some of the places we used to be in our regular contact with in H&I have shifted away from exclusively 12 Step meetings and want us to switch to hybrid presentations, with a panel made up of NA, AA, and religious affiliations, which is against our traditions. We (H&I) have had to stop going into some of these facilities as well, given that we have not been offered new time slots to present just the NA message. We do, however, continue to bring our literature into those facilities and support any new treatment center, ½ way house, or other facility that houses addicts in our area. H&I has always been an area we could improve on with 3 prisons and five county jails in this area, none of which see us on a regular basis. The basic way we have tried to get access to these prison facilities. They always seem to be locked down when we are scheduled to go in there. Could Zoom meetings from the outside be a viable alternative? The recent WSO Motion Tally was conducted at CCC Group on 1-26-25 at our area meeting with 22 participants present. Votes on all 12 motions were taken and tallied, and the results recorded on a single Motion Tally Sheet provided by the Region. I am submitting the results to be counted today along with this report.

In December's ASC, we agreed to donate 10% of our 7th Tradition, after the other expenses, to the Region on a quarterly basis. We have mailed a check to the Region in January in the amount of \$89.24 which you should have gotten by now. A note on our local convention, SETACNA III, on April 10-12, 2026. The convention committee met on Feb. 2nd and filled all our previously open positions on the committee. We are fired up and ready to begin planning. More information will be forthcoming. Also, I was looking at the Regional meeting schedule and noticed

that the Just For Today Group in Beaumont, TX, our area, SETANA, was listed as meeting on Mondays at 12:15. That group does not meet then—it meets on Tuesdays at 12:15. If we could just get that fixed it would be great. Lastly, I am still waiting for access to the TRBNA Trusted Servants messages and documents on the website. I plan to continue printing out my reports till I can email all of you, which would be a better use of my personal resources, and less of a headache for all of you to read, as well.

A table was set up all day on Saturday at Esperanza Area convention and we had a lot of interest and collected names.


We will do a presentation at TBRCNA as well as Texas State Convention & Lone Star Convention.
