Ruben added that in Arkansas they use cards that are color coded for taking consensus which made it run very smoothly. No world convention in 2027. Last one lost over \$1 million. You can check your group's donations at na.org and check the breakdown of motions that passed and failed at WSC. September 6 is Unity Day. PR week is first week of June. Sponsorship Day December 1st. Tariffs currently don't seem to affect printed materials, but preparations are being made for increasing costs. Complete active surveys that can be done from your phone. Subscribe to NAWS updates to stay in the loop. CAR will be out Nov 3.

#### (I missed a lot that I couldn't understand here - Heidi)

Regional recorder would be put on a list so she could get that information directly. There's a disconnect between RSC, Areas, and groups. If you ask at groups what region or area is, a lot of them have no idea. If we can get on that list, we can blast that out to everyone who wants it.

We padded our budgets because we knew we may need more. The costs of putting on a convention are putting us in the red. 1,700 registrations were given to newcomers.

Chris asked what information Ruben was needing from the areas so he can compile his report for world.

Ruben clarified that he needs information about what's been happening in each area over the last few years, since the last WSC in 2023.

Regional Delegate Alternate: Vacant

Chris: Change in order of business so that Ray L. can provide his report from the Regional Inventory Task Group

#### **Inventory Task Group**

Ray L. attending virtually and read the report from the Regional Inventory Task Group:

#### [I had to step away 11:05 to 11:55, so I filled in what I could from the recording ...]

Group met 3 times to brainstorm, and these are the groups suggestions on the 3 topics

- 1. Improving efficiency:
  - Proposals should be submitted as early as possible via email to the entire service body to allow time for discussion and/or amendments prior to regular regional meetings.
  - Increase of straw poll during meeting Not to read all reports word for word and bring items of critical significance to the body for discussion (reports can be read when the record is sent out).
  - Sharing of reports to the <u>all@tbrna.org</u> email sooner than one hour before the meeting.
  - Consider all virtual format meeting in person only once for a 2-day conference.
  - Admin body practice sessions for improving the practice of using CBDM.
  - Create a list of general best practices and/or electronic platform training for virtual meeting behaviors.
  - Sending all flyers to web servant for ease of access by all from a central location. Not waiting on the record to have flyers and information.
  - Timeframe for proposals, i.e. 40 minutes and there are 5 proposals, we spend 8 minutes on each and move on.

#### 2. Lack of respect:

- Challenges are talking over one another, interrupting, blurting out and repeating of ideas only to say why you agree with what has already been stated. Suggested solutions: use of positive productive statements such as the following: thank you, we hear you, I hear you.
- Recess for a 5 or 10 minute break when things become heated or out of order.
- Stop texting the admin body during the meeting which is distracting when we are trying to stay on the agenda.
- Assign a member to assist with managing raised hands for input between virtual and physical attendees so everyone feels valued and respected.
- Stop side conversations and cross-talking to allow all members to remain focused on the task at hand.
- 3. Lack of trusted servant training:
  - Current servants should encourage service in speaking positively and openly about their positions.
  - Create a group of support documents that covers best practices and expectations for RSC service.
  - Schedule new servant training sessions between RSCs to share and review the support documents.
  - Build interest by prior announcement at events as we rotate through each area.
  - Encourage people you meet to sit in on an RSC to familiarize themselves with our processes.

- Announcing the RSC is a support body and that we are readily available to consult on issues as they
  arise.
- Approach others you meet with "you may be really good at (a position) at Region".
- Use the Local Guide To Service. We have a resource and need to practice using it.

I want to acknowledge the work of our Policy Facilitator, whose efforts have brought clarity without compromising the spirit of our traditions and guidelines.

The Inventory Task Group, though I've only witnessed a portion of its work, has brought thoughtful reflection to light. That light—our shared hope and purpose—continues to be held by each of you.

The Convention Contracts Task Group has made huge progress in reaching agreements that will help our convention committees be successful.

At our last cycle, we suspended business due to a disagreement about the precise language used in seeking consensus. It was not about the body's ability to decide, but about how the question was framed. We spent a lot of regional resources to be here and then did not execute our sacred responsibilities, allowing the verbiage I should use to ask for consensus, to be a reason to halt. These are the types of conflicts I believe our Task Groups are poised to help us resolve, and I remain hopeful.

I still see a light at the end of the tunnel, and it is still each of you that are holding that light. Thank you for continuing to engage in this process with care, courage, and commitment.

#### Read his report

The convention Insurance Policy Rider premium was much higher, \$576.38, than the \$200 estimate I reported in February. There was a ten-cent bank adjustment, leaving our end-of-cycle balance at \$1783.84

Please review the included register and let me know if you need clarification.

There is a payment missing. I did not attend the Regional Inventory and am unclear about the arrangement with the presenter, Sarah. Please guide me.

Our Balance this Quarter dropped to a dangerously low level, and I had to make some decisions to keep it afloat.

- •I held off on paying the Texas Sales Tax until we had a higher balance and received sales totals from the 26 Convention. Since I made that call, I will pay the penalty out of my pocket.
- •We did not have the funds to pay our AAI invoices from HASO, so I paid \$491.75 out of pocket. I will be requesting reimbursement.

The Convention made their donation for the 2025 event. \$14,934.67.

The starting balance today is \$15,348.99, and the working balance is \$10,848.99.

Contracts - Randie Benno

I was asked by Admin to work on obtaining Contracts for the current and the next three TBRCNA's to bring us up to date.

2026

The next year's convention was completed after a site visit and negotiation with the best property. Many requests for proposal (RFP) were sent out by myself as well as the committee. I met with Chris and Kent to explain and present the process I went through and best the recommendation. That contract has been signed, deposit sent and TBRCNA 25 has a hotel! (*Corrected verbally by Kent to TBRCNA 26.*)

2027

6 RFP's were sent out and proposals reviewed. We looked at College Station, Round Rock, Georgetown and Austin. Michael S. joined me at two of the properties I felt were the best to pursue. We both took a site tour and negotiated. The one property that we have been in the past was formerly the Omni in South Austin. They have been bought and it will become a Hilton property. She is unable to give me a new proposal until the new management company decides which brand they will be. I have heard they will be a more posh brand that would put them out of the running. They are really a little too small if we are to grow as well.

The hotel I have recommended is the Doubletree Hilton in North Austin. It is a beautiful property that has recently remodeled their lobby and meeting space. In order to stay with a quality hotel, with the space we require, Registration and room rates will more than likely be increased in the future. As you may have heard for a while, the hotel industry has changed and there are fees and charges for many items we used to get for free, such as parking & meeting space. Food costs and minimums have also risen drastically. Bringing in our own food is an ongoing issue as well. The reduced priced for coffee is around \$75.00 a gallon. We need to look at having a breakfast again on Sunday and need commitment to attend.

We can also apply for a Hilton Honors Business Account, although it would be under an individual person's name as well. We could get double points for this stay. We could talk about who would be the appropriate person to set this up.

2028

3 RFP's were sent out, one with no response. I did take a lookin Galveston but prices were up to 30,000 for Food and beverage ++. It looks like the best proposal is for the Elegante in Beaumont. I received an updated proposal after negotiating and it looks good to go.

2029

One RFP was sent out and I am working with the Omni in Corpus Christi at this time to negotiate. There is not another viable property in the area.

I have worked on the Archives for the last convention in Houston with Kammie's help. All these facts and figures will help with ongoing contracts, negotiations and planning of the current convention.

Thank you all for this opportunity to assist this Region in work that I love doing.

I have submitted two gas receipts to the Treasurer for reimbursements: \$40.75 & \$41.30

I do not foresee any more travel to complete this task.

Chris explained that Randie's made an effort to make a guide to use for this process going forward. If we want to have a standing committee for this, we'll need a proposal.

The RCM's in conjunction with Fellowship Development plan to combine our efforts in visiting with, and providing support for some of our outlying Groups. We have spoken with the Fellowship Development Facilitator in order to provide a two-tier approach to insure this commitment is implemented and maintained.

Gilbert explained that it doesn't make sense to have the Contracts and Archives Committee (CAC) in the Convention Guidelines where they are now. So, the proposal is to move those back to regional policy/guidelines and adopt the proposed revised guidelines.

Megan asked why it was removed in the first place.

There was discussion that they thought it would work better, but instead it created tension over the roles of the Contracts and Archives Committee vs the convention committee.

Patsy explained that there were no archives turned in after the last 2 conventions and no formal report to RSC.

Kent explained that the CAC should have a business account with hotels so we can earn points for the region.

Roberta asked if the position being created would be a regional position and would have access to previous contracts.

Chris explained that they'd be responsible for creating the contracts.

Chris asked if there were any reservations. None expressed.

Chris asked if we have consensus. **Proposal passed.** 

Remove the Service Pool as a standing subcommittee and have the policy removed from the Tejas Blue Bonnet Region. Reason: It is not being used. Total of 12 submissions and only 2 submissions in 2024.

Chris read proposal.

Asked for clarifying questions.

Asked for reservations.

Chris asked if we have consensus. **Proposal passed.** 

Proposal #4 -

Chris read proposal from Richard:

Would like to propose that he be reimbursed for his room and travel expenses going to the TBRCNA Convention on Feb 14-16 in Houston. He will be assisting with the RD on Saturday morning presentation conducting the virtual portion of that presentation.

Requesting reimbursement of \$150 for hotel and gas. Explained that there is no budget for IT, but he attended TBRCNA in that role.

Any reservations.

Consensus. Proposal passed.

Proposal #5 -

Read proposal.

When it is fiscally prudent, a second Owl will be purchased to allow the RSC to better accommodate varied venue configurations. This will also provide additional hardware for use by other subcommittees and delegate team presentations.

Kent said we need clarification on who can borrow the Owl (only regional committees? Or areas within the region?)

Buying a new Owl or refurbished?

Chris said there haven't been upgrades but there's been an update.

Bart said an upgraded camera would be nice because it's so blurry.

The price is fluctuating a lot right now, so the don't have a solid quote.

Ruben said problem in Pasadena workshop, Richard had to go out of his way to drive it to him; then Ruben had to get it back to Richard in time for this RSC. So, having a 2<sup>nd</sup> one would be helpful.

Chris asked if we have consensus.

We have consensus to buy one when Tom says we can afford it (when it's prudent).

Proposal #6 -

Chris read proposal from Ruben.

Ruben P. has proposed the purchase of the projector (\$600) for use at various functions. He will submit a formal request written before these minutes go out. (Not yet received by Recorder).

Ruben asked to change it to \$500.

Deanna asked if this was a slide projector.

Chris explained that it's to project images on the wall like.

Chris asked what condition the projector is in. Ruben said it's like new because it's basically only been used at region.

Deanna asked what the purpose was.

It was explained that it is to project Zoom meetings for those attending in person and to make presentations.

Chris asked for reservations. There were two.

Kent took attendance at 14. 80% of 14 is 11.

Chris asked for consensus again. Proposal passes.

Proposal #7 -

#### Region to pay damages at RFATX to avoid making an insurance claim.

A homegroup that was meeting there was responsible for the damage.

Patsy asked if the group couldn't pay for it.

Kent said it was the noon meeting, Just for Today.

Chris explained that Rolando was contacted by Just for Today that someone leaned back in a chair and broke a window. The landlord fixed it and billed RFATX for \$1,700.

Patsy asked Chris, RAFTX board member, why they contacted Chris. Chris explained that they had not contacted him, but had contacted all of the RFATX Board.

Chris explained that the group is responsible to RFATX for the damages. The group is covered by the TBRNA insurance policy, so the region should have a claim filed for the damages.

Patsy said it would have been more appropriate for the group to take it to CTANA, and CTANA should have brought the issue to the RSC.

Karla asked if Admin had a vote. Kent said Admin can't vote on OLD business. The proposals that are now in NEW business (because business was suspended last RSC, which caused confusion),

Bart asked if it was an area event and suggested that the area and region pay half, and he asked what our deductible is.

Chris said the part of policy impacting who has a voice regarding consensus on proposals did not change. So, everyone had access to that policy information. If we had not suspended business last RSC, the proposals would have gone back to the areas; but that didn't happen, so the proposals were in NEW business and Admin could vote.

CTANA rep said they want to take this proposal back to CTANA.

At CTANA, when Karla is giving her report, some RSC Admin speak at area and cause confusion. So, he asked that they not do that anymore.

Kent said he only spoke about RSC matters at area when he was asked to.

The risk of not paying for the damages is not the cost of a deductible, because there is none. The risk is having the policy cost go up or get cancelled. We should reserve claims for catastrophic events.

Chris asked for reservations.

There were several and lots of discussion.

Kent re-read the proposal to be taken back to areas.

Proposal #8 -

#### **TBRCNA Guideline Proposal**

Victoria C. - Updated Tejas Bluebonnet Regional Convention Committee Guidelines

Chris explained that this proposal is to accept the emailed guidelines sent April 22<sup>nd</sup>.

Chris asked for clarifying questions.

Reservations. None

Consensus? Yes, passed.

Proposal #9 -

#### Increase TBRCNA 26 seed money to \$18,000.

Gilbert explained that when he was chair it increased from \$10k to \$12, and now everything has gone way up. Things that used to be free are now charged for.

Bart explained that the seed money used to be for a downpayment and would pay the rest right before the convention started; and wondered if that has changed.

Proposal #9 - Continued

Gilbert explained that the hotels won't let them do that anymore. Plus by policy they now pay for rooms for certain trusted servants.

Chris asked for reservations.

Proposal will go back to the areas.

Proposal #10 -

#### Add IT budget of \$500 per quarter to align with other subcommittees.

Wll go back to the areas.

Roberta asked what the \$500 would be used for.

IT's job is to travel and assist with IT issues.

Patsy appealed the facilitator's decision that it would go back to the groups because the policy already says that all subcommittees have a budget.

Policy (Karla?) said policy says if 20% of RCMs want to take a proposal back to their area, it goes back.

There was discussion over whether the facilitator made a decision or not.

Proposal goes back to areas.

#### **Treasurer's Update:**

Tom asked if they should consider holding back some of the profit from TBRCNA since some bills are coming up and funds have been low. If we don't, we'll follow policy and send the donation to NAWS.
