Administrative Reports

RD Report:

Over a month ago I sent e-mail out to the Regional Committee members about the Literature review input asked for by NAWS on "In Times of Illness", "Self Support project" and the "Living Clean Project". I received no response from anyone in the region for clarification or any other kind of information. So I assume everyone found the information on NAWS website with no trouble and got your input in already. If not, you have until the end of May to send it in. Just in case you didn't get the information it's at www.na.org. Click on the green box, "What's New". Look under "World Service Conference" (it's in the left column), then go to the "projects" link. There is another link, and it tells you the instructions. You may have to use "WSC 2010" as both user name and password.

I have been informed by NAWS of the importance of starting a dialogue now concerning the possibility of nominees for World Board, HRP or WSC CoFacilatator. We will only have the August RSC to discuss any nominees we might want to send in. The reason

this is so important is that nominations are due to the HRP before the end of October. There is a new form the HRP is requesting we fill out and send in with each nominee. I'm attaching a copy of that form to my report. Regional nominees bypass the blind screening process, and go directly into the HRP interview process. If you know of a person who would be a good candidate, please see if they are interested, then bring the completed form with you to the August RSC, so we can discuss whether we want to nominate that person.

If you have not updated your World Pool Information Form in the past 3 years, you probably received an email from NAWS. They decided to do this by email to save postage. If you have 5 years clean, please put in a WPIF. This can be done online.

I received a request from NAWS to update our Area's information, including address, contact person and web page. I have finished that update, and have sent it to NAWS. Each RCM can update your Area's information online, and it is suggested you do so every time there are changes in your trusted servants.

I have received no requests for workshops regarding the Issue Discussion Topics this quarter. I hope that means that everyone here today is going to be here tomorrow for the Issue Discussion Workshop. This was, after all, your decision to try this experiment.

I was very graciously thanked by NAWS for the input they have received so far from us on the previous IDT workshops. I would like to keep up the good work. After some discussion on this issue Dawn and I have decided to cover the IDT "Our Freedom, Our Responsibility" and "Building Strong Home Groups" at tomorrow's workshop. The reasoning behind this is something she brought back from the World Wide Workshop she attended in California.

Hello everybody, it's great to be here with ya'll today.

Let's start with the World Wide Workshop I was able to attend Feb 27th thru March 1st. It was a fun packed busy weekend getting started the night I arrived. There were many topics offered to participate in including this conference cycle topics, the Living Clean Project and Medication and Recovery. The weekend started off with Building Stronger Home Groups. The presenters wanted to remind us that this workshop continues to benefit the fellowship as a whole and just because most of us involved in service have had the opportunity to participate in this workshop, every time we have newcomers start attending our Home Groups that this is a good way of getting them to feel a part of and learn the importance of each member. This is one reason that we choose to add it to the line up for Sunday as a refresher.

There are ways online at www.na.org to get involved and give your input over the various projects that are being developed by the fellowship. When you go to the web site go to World Service Conference then pick the topic you want to review first. Living Clean Project lets you participate by answering 5 questions. Other options include In Times of Illness and Self Support. I believe that timelines are drawing to an end soon, so if you are interested, act soon.

Furthermore, over 2500 people are registered for WCNA33 and dates to purchase preregistration merchandise has been changed from May1st to June 15th. This year registration for the convention pays for all events. Also anyone registered will have to pick up their own registration as this has changed from past conventions. Preregistration ends July1st.

Today, I am turning in receipts for hotel, food and taxi while in Oakland for \$378.70. Also gas receipts for travel to this RSC.

I will start planning soon for travel to the July SZF that will be held in Bentonville, Arkansas. No flights go to Bentonville, so I'm planning to fly into Tulsa, rent a car, drive 1½ hours, plus a motel room. That would cost \$421.00. I might got to Dallas and ride with people from Lone Star.

Co-Facilitator Report:

This has been an eventful quarter for me. I attended the Ad hoc convention policy committee meeting online, which was really neat and I missed one of the meetings due to some confusion on my part. I attended the Texas State Convention Advisory Board meeting on April 25th in Fort Worth, Texas. As usual I emailed everyone and asked if there was anything that anyone wanted me to take to the Advisory Board meeting and no one had anything. The next meeting will be in Universal City on June 27th at 810 Kitty Hawk. The time will be from 12:00 PM to 6:00 PM.

The TSC Advisory Board meeting began at 12:30 PM. They are in the process of moving their PO Box as the mail is still going to Austin. The PO Box will be moved to what ever town that the new chair lives in. This will not be done until a new chair is elected at the next meeting in Universal City. TSC received a bankcard in the mail and there was a lot of discussion on what to do with it. The decision was to cut the bankcard up.

The decision was made by the body to turn their website over to a professional. The vice chair handled this project as they were having problems keeping their website up to date. Three bids were taken and a decision was made at this meeting. So their website will be kept up to date and have some changes made that will help their Conventions.

The secretary has asked all of the Advisory Board members to email her their reports. This will make her job a lot easier. As soon as I get the minutes from this meeting I will email everyone a copy. All of us should be doing the same in our region.

The policy Chair had just moved and wasn't prepared as he brought the old policy instead of the current policy. The treasurer was a no show as she said she was at the emergency room. We hope that she is OK. The Convention Chair for El Paso reported that they had half of their room block filled and had some problems with the hotel in the evening hours taking reservations as the answering service was answering the phone and had no information about the Convention and was giving the wrong information. This problem has been solved. So if you know of anyone who had problems they can call the hotel and get the correct information now. They need the support to fill their room blocks. Coffee will only be served in the Hospitality Room. They have limited their merchandize to t-shirts and coffee mugs as the registration is at 106 at the present time. The Chair stated that El Paso is safe, but Juarez isn't. The Convention hotel is across the street from the Air Port. They need auction items for the convention. These can be mailed to the convention PO Box listed on their website.

It was decided that each Convention Committee will be responsible to open their own bank account when they receive the convention seed money. They will be given the money to open a PO Box before the close of the current convention in order to have a box to send registrations to for the next convention. The 2010 Convention Chair from Austin was present and gave her report. At the previous Advisory Board meeting the Convention Chair and Secretary were selected for the 2010 TSC in Austin. The Vice Chair and Treasurer will be selected at the June 6th Central Texas ASC in Austin.

At the next TSC AB meeting a new AB Chair and AB Member at Large will be selected. The TSC AB appreciates TBR sending a representative to the AB meetings.51.00 travel to TSC AB, 28.00 motel, 23.67, 6.00 copies, 57.67 total for RSC, 118.67 grand total.

TBRSC AGENDA will be set, typed, and mailed 30 days prior to each RSC, along with meeting location and information, in order to expedite short meetings.

Treasurer Report T.B.R.N.A. TREASURER'S REPORT MAY 16, 2009

Good morning. I am glad to report our Bank Statement and Register balance. Our beginning bank balance for

Feb. 2009 = $5,273.89/ending = $3,988.89,

Now, after half of the **\$10,801.79 donated from TBRCNA 09** (or \$5,400.90), is donated to NAWS (by our policy) that will leave \$11,409.25 (minus our **prudent reserves** total of **\$2,500.00**) gives us \$8,909.25. After our meeting expenses today, we will donate 20% of the balance to NAWS. So, by my best guess (if \$500.00 covers today's expenses) we should still have approximately \$8,509 25 (minus 20%) leaves \$7,207.40.

The bank statements and reconciliation details are available to anyone who wishes to see them.

We received a \$1000.00 donation from the Plains Area Service Committee (PASC of the O.K. Region) of N.A. They stated: "We, at the Plains Area service Committee of Narcotics Anonymous in the OK Region, would like to make a donation to your service body to help with the damages you accrued from the devastating hurricane. We believe very strongly in reaching out to the addicts who are suffering and coming from an area where devastation can occur instantly with tornados; we understand. Please accept our offering to help replenish whatever needs you may have. Together, **WE CAN!**"

We received a Certified Letter from NAWS (\$5.33 postage) regarding **NA Human Resource Panel. The deadline for receipt of potential candidates from RSCs, Zonal Forums, and the World Board is 31 October 2009**. The letter being certified is big in that they may not be getting much response from the fellowship as a whole? (*Margaret responds no, HRP wants to be certain everyone got it.*)The letter is with me and available to you.

The Office of the Secretary of State (Hope Andrade / secretary of state) on February 11, 2009 sent documentation of: Change of Registered Agent/Office (The Tejas Bluebonnet Region of Narcotics Anonymous), the receipt of the \$5.00 payment, and the Official Certificate of Filing. We can request a file-marked copy of our document.

The Regional Mailbox is in south Austin, which is 120 miles from my house. I have spent \$40.00 in gas since the last RSC traveling twice to the P.O. Box for the mail. Now, Susan G. travels regularly to Austin and San Antonio and will have keys to the TBRNA mailbox to facilitate the transfer of the Regional mail to me. This was discussed with our regional facilitator who stated "sounds like a good idea to me". We can temporarily forward the regional mail to me and cancel anytime, I believe, if you will allow me to. Please give me some direction on this matter, as it will save the region money and save me and Susan time.

Web-Dude:

You might have noticed a new look to the website on our new domain, www.TBRNA.org. I have to thank my TBR beta testers that helped me a bunch as I was putting this together. I received lots of great input from Ben, Albert, Dawn and Allen. If you haven't visited yet, do so. Click around as there are some nice little additions with more to come.

The convention has its own domain now, www.TBRCNA.org.

I have sent out meeting list database dumps for each of the areas to update and also have provided printouts. These are a little different this time and I will tell you why. We are transferring our meetings over to another database/meeting search application called Basic Meeting List Toolbox. This is the creation of Chris M. from the Suffolk Area on Long Island. I gave him a little input, but can nowhere be even closely, considered an author of this incredible project. Some of you have seen the basic workings of this system on the demonstration link that is currently up on the site.

The advantages of this application relative to our existing system are too numerous to name. A few of the major points:

- Simple search function that searches all fields.
- Advanced search by weekday, format and service body.
- Results page offer maps, formats, duration, GPS coordinates, etc.
- You can "Search by Map"; A Google Map that shows markers for every meeting location
- Clicking on these meeting markers displays, once again, lots of information

I am passing around a front end user guide that exemplifies the features of the application. After its gone around you are welcome to steal it.

This application relies on two major data types that we currently do not use (very well.) In order for the "Search by Map" to return your home group, the global positioning coordinates need to be in the database. Chris wrote a translation script that converted most of our meeting addresses into longitude/latitude pairs, but 41 of 616 meetings did not return coordinates. This is caused by non-existent addresses, incorrect terms or the use of descriptions, like intersections instead of addresses. For example, if an address is given as "123 45", instead of "123 Texas Highway 45" or a description like "Across from the drug store". It is pretty easy to find these coordinates by using Google Map or a GPS and I have attached short instructions on how to do this. Essentially find the location on Google and email me the link.

The second issue is the inconsistency of format codes. The letter codes mean different things in different Areas. I have attached a standardized legend. Let me know if you have a format that is not on the list and I will get it added. Please update your meetings with these codes.

The administration section of this system is incredibly robust and easy to use. If you have tried updating meetings on the NAWS maintenance portal you will be amazed at the simplicity of this program. The vision to have every Area update their own listings on the regional server. Someday, we will have one database for all meetings that will be maintained in one location. Say "goodbye" to list discrepancies.

Plugins are already built that allow any area to display this application on their site by querying the regional database server. The demonstration I have on the website is linking to a server that Chris has somewhere east of the Sabine. We soon will have our own server that will service our region only. From that point, we can expand out to include our neighboring regions and possibly the Southern Zonal Forum. The vision is to have the whole world using a common database schema with the ability to tap into one global meeting data system. Kind of like the Internet.

Everyone has a new email address, <username>@tbrna.org except the Convention Facilitator. Hers is facilitator@tbrcna.org. I have printed out some user guides and username lists for those that did not receive them via email.

We have been testing out forum applications for the upcoming Tejas Bluebonnet Regional Community Forum and think we have found a very nice solution in phpBB. So stay tuned for that addition to the web site. Allen is real interested in becoming the administrator of the forum. **Consensus was "yes."**

Can I have a subcommittee? It will be cheap because we could have net meetings like the Convention Advisory Ad Hoc does.

Consensus is "Yes". It was suggested that Area web servants be part of the subcommittee. There needs to be a policy change, and the committee needs guidelines. There would not be much of a budget, only travel to RSC and Web hosting. Both of these budget items are already covered in policy.

A CAR workshop and sharing session is certainly needed but in the electronic age group tallies can be harvested much more economically and closer to the WSC. Maybe our methods of completing this could be a decision that the RSC makes in the previous November as the way we do things change rapidly.

Intent: The methods we are currently developing to pass on knowledge and experience from workshops at the Southern Zonal Forum does not include a workshop at the February RSC.

#3 Proposal: Change the following text on page 8 and page 14

RD and RD Alternate will be elected every two years (even numbered years). Elections will be at a **Regional** Assembly one month prior to the World Service Conference. This vote will be a consensus of all GSRs and RCMs present at the Regional Assembly. The newly elected RD and RDA will assume their duties at the RSC immediately after that WSC. The RD Alternate will be the RSC's one representative to the Southern Zonal Forum.

In even number years, the RD will give a comprehensive WSC report.

#4 Proposal: Add the following text on page 9

Add under:

Removal of a Regional Trusted Servant

An Administrative Trusted Servant or Regional Subcommittee Facilitator may be removed by a 2/3 paper ballet vote. Note: The trusted servant shall be given a rebuttal time of 10 minutes. If the servant is not present the RSC can choose, by consensus, to remove them without rebuttal.

Intent:

If the trusted servant is not present, is it OK to remove them, anyway? I think so, but what if there is a case where someone objects to removing them when they are not present? Shouldn't we state that they can be removed even though they are not present, provided the group conscience decides it?

All the RCM's Regional Subcommittees and Regional Staff meet every 3 months to discuss reports, concerns, and events for those Areas that are supported through the Lone Star Region. This is a two day meeting. I do have all the reports from other Areas other than ours. I will send these upon requests. Also, the Lone Star Convention Committee report was given.
